

Included in his interactive session will be reflections on meeting FOCUS' DOMAIN #5 - GOVERNANCE & LEADERSHIP with a sprinkling of other Domains so to address topics such as risk management, and fiscal management. This session will speak to ED's, Board Members, Peer Validators for onsite validations, and for those people in your organization who are responsible for meeting the Governance and Leadership FOCUS standards. Come with a list of Board challenges and questions and be ready to ask about them.

Tom Little is the author of Tom Little's BIG Ideas for Non-Profit Boards and Tom Little's BIG Ideas Newsletter. He is also the President of CMCS Consulting Services. CMCS provides strategic and operational planning assistance. It offers training for Boards and Executive Directors. CMCS facilitates Board and management retreats, advises on organizational structures and undertakes special research and evaluation projects. Since 2012 CMCS has helped 22 community organizations create strategic plans.

Changing Patterns in Leadership & Organizational Change in the Social Sector - Exploring What Comes Next 1:00 pm - 3:00 pm

Taking a hawk's eye view of the Canadian social sector can help us to see out over the rapidly changing landscape to locate the strategies and practices that will keep our organizations serving the people we care about. Where stability was once a goal, now resilience - the ability to shift practice, find and take opportunity, and work with others all while staying laser focused on mission - describes some of the hallmarks of successful organizations. This workshop includes a "theory burst" illustrating some of the changing patterns seen from the 10,000 foot level to set up a rich facilitated conversation exploring what participants see changing on the ground and the emerging capacities and practices people are developing to respond.

Marilyn Struthers is the principle of M. Struthers & Co. where her work includes project development and organizational change coaching for leaders, as well as consulting on organizational development and strategic initiatives that support sustainability in social sector organizations. She has worked in the non-profit sector for more than forty years, engaged in fields as varied as women's safety, Children's mental health, the arts, First

Nations' Issues and innovation. Her work has spanned community organizing, organization building, and participatory approaches to learning, governance, program and leadership. She was the Inaugural John Eaton Chair Social Innovation in and Entrepreneurship at Ryerson University. Before joining the University she spent 14 years as a funder with the Ontario Trillium Foundation where she held a \$4M/year portfolio making provincial investments in social change and community service organizations to build the social sector's capacity to innovate. Using the "landscape view" her work has afforded, Marilyn is also a researcher, writer and speaker.
